Day 1 (9/7/2021):


1. P. 45, line 10 – should be “regionally” not “reasonably”

5. P. 177, line 8 – should be “or”, not “our”
6. P. 186, line 3 – should be “same”, not “statement”
7. P. 207, line 1 – should be “confer”, not “confirm”
8. P. 222, line 3 – should be “referred”, not “affirmed”
9. P. 244, lines 5 and 12 – should be “real”, not “rural”
10. P. 246, line 17 – should be “issue”, not “issued”
11. P. 246, line 22 – should be “in lieu of”, not “issue”

Day 2 (9/8/2021):

- 12. P. 258 – date should be September 8, 2021
- 13. P. 301, line 3 – should be “non-native turf grass”, not “not native turf grass”
- 14. P. 305, line 25 – should be “\$500,000”, not “\$5,000”
- 15. P. 307, line 6 – should be “drain fields”, not “drain holes”


