- Staff 1-2 Please provide the specific reasons that CSWR is in a loss position. For each reason, provide the dollar effect on annual revenues and the estimated dollar effect on revenues for the next two years.
- Staff 1-3 Please provide a list of each plant amount supporting the totals reported in application 11. B., including the following:
 - a) Date in service;
 - b) Original cost, and
 - c) Accumulated depreciation amount.
