COMMISSION STAFF'S FINAL RECOMMENDATION

On July 29, 2020, the City of Pharr (Pharr) and the City of San Juan (San Juan) (collectively, Petitioners) filed a petition for approval of a service area contract under Texas Water Code (TWC) § 13.248 to amend their sewer certificates of convenience and necessity (CCN) in Hidalgo County. Specifically, the Petitioners seek to dually certification of an portion of San Juan's sewer CCN number 20643 and Pharr's sewer CCN number 20791. The Petitioners' service area contract is being reviewed in accordance with 16 Texas Administrative Code (TAC) § 24.253. The requested area is approximately 4,620 acres. On January 22, 2021, Pharr and San Juan each filed a signed consent form.

On January 14, 2021, the administrative law judge filed Order No. 5, which established a deadline of January 29, 2021 for Staff to file a final recommendation on the petition. Therefore, this pleading is timely filed.

I. RECOMMENDATION ON FINAL DISPOSITION

Staff has reviewed the petition, and as detailed in the attached memorandum of Alicia Maloy of the Commission's Infrastructure Division, Staff recommends that the petition be approved. Staff further recommends that the Petitioners each file a certified copy of the attached CCN map, along with a written description of their respective CCN service areas in the Hidalgo County Clerk's Office, as required by TWC § 13.257(r) and (s). Copies of the final map and certificates consented to by the Petitioners are attached.

II. CONCLUSION

For the reasons detailed above, Staff respectfully requests that an order be issued approving the petition.

On July 29, 2020, the City of Pharr and the City of San Juan (collectively, Petitioners) filed a petition with the Public Utility Commission of Texas for approval of a service area contract under Texas Water Code (TWC) § 13.248 and to amend the City of Pharr's sewer certificate of convenience and necessity (CCN) No. 20643 and the City of San Juan's sewer CCN No. 20791 in Hidalgo County, Texas. The Petitioners' TWC § 13.248 service area contract is being reviewed in accordance with 16 Texas Administrative Code (TAC) § 24.253. The total area being requested includes approximately 4,620 acres and no current customers. The City of Pharr and the City of San Juan have agreed to dual certification to allow the City of Pharr to provide sewer service to new development in the area requested.


Individual notice was not required for this petition because there are no affected customers in the area subject to the agreement. The Petitioners submitted the meeting agenda and minutes of the Petitioners' respective city council meetings where the service area contract was approved to satisfy the notice requirements under 16 TAC § 24.253(c).

The petition meets all applicable statutory requirements of TWC Chapter 13 and 16 TAC Chapter 24 rules and regulations. Therefore, I recommend approval of the petition.

The Petitioners consented to the attached map and certificates on January 22, 2021.


