COMMISSION STAFF’S STATUS REPORT

On August 10, 2020, Shaneka L. Busby Baker (Ms. Baker) filed a formal complaint against the Veranda Apartments (The Veranda) and Denton Public Facility Corporation (DPFC) (collectively, parties) for charges regarding water service.

On May 24, 2021, the administrative law judge (ALJ) filed Order No. 10, establishing a deadline of June 21, 2021 for Staff of the Public Utility Commission of Texas (Staff) to file a status report on the settlement negotiations and propose a procedural schedule for further processing, if appropriate. Therefore, this pleading is timely filed.

I. STATUS REPORT

Staff has conferred with the parties and been informed that a settlement has been reached. The parties are currently finalizing the documents and ledgers which are subject to the settlement agreement. Staff anticipates all outstanding processing will occur in short order. Per the terms of the agreement, Ms. Baker has agreed to dismiss the complaint in this case.

II. PROPOSED PROCEDURAL SCHEDULE

In light of the parties’ settlement of this matter, Staff proposes that a deadline of July 12, 2021 be set for Staff to file a subsequent status report in order to allow Ms. Baker to file a request to dismiss the complaint and the ALJ to rule on such a request.

III. CONCLUSION

Staff respectfully requests issuance of an order setting a deadline of July 12, 2021 for Staff to file a subsequent status report.
