RESPONSE OF JOHNSTON & ASSOCIATES, LLP AND FRANK CARVALHO TO ORDER NO. 7 AND REQUEST FOR EXTENSION

COMES NOW, Johnston & Associates, LLP and Frank Carvalho, jointly, ("Petitioners"), and file with the Public Utility Commission ("Commission") this Response to Order No. 7 and Request for Extension.

Petitioners respond to the Administrative Law Judge's inquiries as follows:

1. The legal name and all assumed names, if any, under which each petitioner conducts business, including any assumed name(s), and provide a currently valid certificate(s) of assumed name(s), if applicable.

RESPONSE:

- (a) Frank Carvalho is an individual and has no assumed names.
- (b) Johnston & Associates, LLP has filed assumed name certificates with the County Clerk in Bexar County (Johnston Legal Group, PC), Harris County (Johnston Legal Group PC), Lubbock County (Johnston Legal Group PC), and Tarrant County (Johnston Legal Group PC). These certificates are attached as **Exhibit A**.
- 2. The form of business in Texas (e.g., corporation, partnership, sole proprietorship), charter or authorization number, date business was formed, and date change was made, if applicable.

RESPONSE:

- (a) Frank Carvalho is an individual (and therefore, this question is inapplicable).
- (b) Johnston & Associates, LLP is a Texas limited liability partnership. The SOS file number assigned to that registration was: 800433911. The business was formed on December 30, 2004. See Exhibit B. There were no changes made. The limited liability partnership registration of Johnston & Associates, LLP, file number 800433911, expired on 12/30/2010. See Exhibit C. Johnston & Associates, LLP was made aware of this expiration upon inquiry after the ALJ issued Order No. 7 in this matter. The General Partner for Johnston & Associates, LLP, Michael Johnston, requested that the Secretary of State reinstate Johnston & Associates, LLP. Unfortunately, before the Secretary of State will reinstate the entity, a tax clearance letter must be obtained from the State Comptroller's Office. Michael Johnston has requested this tax clearance letter. See Exhibit D. The Comptroller's Office informed Mr. Johnston that it may take some time before he will receive the tax clearance letter. Once he receives the Tax Clearance Letter, Mr. Johnston will submit the required information to the Secretary of State. Petitioners request, therefore, that the ALJ grant an extension of 10 business days (until December 8) for Petitioners to resolve this issue with the Comptroller's Office and the Secretary of State.
- 3. Legal name of parent company, if any, and a description of its primary business interests and the name of any companies affiliated with the applicant with which it does any business. Provide the state and date in which the parent and affiliated companies are registered.

RESPONSE:

- (a) Frank Carvalho is an individual (and therefore, this question is inapplicable).
- (b) Johnston & Associates, LLP has no parent company. Its General partner is Michael Johnston, an individual.

REQUEST FOR EXTENSION
