### RESPONSE OF JOHNSTON & ASSOCIATES, LLP AND FRANK CARVALHO TO ORDER NO. 8

**COMES NOW**, Johnston & Associates, LLP and Frank Carvalho, jointly, ("Petitioners"), and file with the Public Utility Commission ("Commission") this Response to Order No. 8 (which required a Response to Order No. 7).

Petitioners respond to the Administrative Law Judge's inquiries as follows:

#### **RESPONSE:**
