### Dear Reviewer:

The responses to the items from the PUC Request for Information (RFI), dated November 6, 2020, page 5 of 5, are as follows:

Staff 2-1: Please file in the docket a copy of the Texas Commission on Environmental Quality (TCEQ) approval letter for the construction plans and specifications of the new facility that will serve the requested area and the installation of distribution lines.

A copy of the TCEQ approval letter, Plan Review Log No. P-07222020-156, dated September 22, 2020, for the construction plans is provided as Attachment 1.

Staff 2-2: Please provide the total capacity of the well(s), storage tank(s), pressure tank(s), pump(s), and elevated storage tank(s) for the PKWSC's current service area under certificate of convenience and necessity number 12890.

The total capacity of storage tank(s), pressure tank(s), pump(s), and elevated storage tank(s) for the PKWSC's current service is found in Attachment 2; it is the Water System Information for PKWSC obtained through the TCEQ Drinking Water Watch. There are no wells in the PKWSC system. The source water for the water treatment plant is surface water from Possum Kingdom Lake which is indicated in the attachment.



Staff 2-3: Please admit or deny that PKWSC's current number of customer connections in its existing CCN area is 2,707 connections.

The PKWSC's current number of customer connections in its existing CCN area is 2,719 on November 19, 2020 which is the date the attached Application's Oath is signed. The number of current connections fluctuates but generally has an increasing trend.

Staff 2-4: Please provide the total capacity of the well(s), storage tank(s), pressure tank(s), pump(s), and elevated storage tank(s) that provide service to the requested area.

The total capacity of the well(s), storage tank(s), pressure tank(s), pump(s), and elevated storage tank(s) that provide service to the requested area is shown on the bulleted list in the second paragraph of the TCEQ Plan Review Log No. P-07222020-156. The approved project consists of a 17,000 gallon ground storage tank, a 1,700 gallon hydro-pneumatic tank, and two 20 horsepower booster pumps rated at 170 gallons per minute each.

Staff 2-5: Please admit or deny that the requested area includes an additional 168 customer connections.


Currently, the requested area includes an additional 170 connections. There was a miscount of the connections in the original application. See the Additional Item response below for details regarding an anticipated minor change in the number of proposed future connections.

Staff 2-6: Please provide copies of any exception approvals received from the TCEQ for capacity or any other TCEQ rules.

A copy of the Alternative Capacity Requirement (ACR) exception approval received from the TCEQ, dated July 3, 2013, is provided as Attachment 3. This is the only know current exception approval from the TCEQ.

Additional Item: On November 16-17, 2020, the PUC staff Mr. Daniel Moore asked for an explanation of why the requested area is over 1,000 acres and the number of additional connections within the expansion area was 168.

The CCN expansion is to accommodate a new subdivision, Water Ridge Estates. The new subdivision area is 166.848 acres. The total area within the CCN expansion request is 1,099 +/- acres. The preliminary plat included in the application shows 170 proposed future connections as indicated in the response to *Staff 2-5* above. The plat will be adjusted in the near future with the phase lines to be shifted due to the Texas Department of Transportation's (TxDOT's) recent comments indicating that it would not approve two access driveways onto State Highway (SH) 16 in such close proximity in the Water Ridge Estates Phase 1. The Phase 1 lots will be reworked to possibly add a cul-de-sac on Water Ridge Drive such that the one access road onto SH 16 will be from Green Elm Road. With this change, additional homes will be included into Phase 1 on the east side of Green Elm Road.



A copy of the referenced plat is included in Attachment 4. Although adjusting the plat may affect the total connections  $\pm$  5, adjusting of the plat does not affect the TCEQ's approval of the infrastructure construction plans and specifications. The Water Ridge Estates developer intends to move phase by phase until the entire subdivision is built. Therefore, the entire subdivision area needs to be included within the CCN amendment. An aerial view of the approximate location of the subdivision within the requested area is found in Attachment 4. The outline of the 166.848 acre subdivision is approximated by a purple line within the blue-shaded CCN area. At the start of the process, the Possum Kingdom WSC marked on a CCN map to indicate the expansion area by "closing off" the area between two corners of its CCN within which the Water Ridge Estates subdivision is located. See Attachment 4 for a depiction on a copy of the PUC CCN map. Possum Kingdom WSC does not currently have additional customer service requests within the requested area other than the Water Ridge Estates subdivision request.

Per the RFI Instructions Item 1 on page 4 of 5, the RFI is provided under oath; see the attached Applicant's Oath in Attachment 5. Responses to the RFI are provided by filing with the Commission through the Interchange on the Commission's website by the 20-day deadline of November 26, 2020. Since the filing is less than 50 pages it is not considered voluminous and per Item 7 in the RFI Instructions, no hard copy and no Table of Contents are required as verified during a conversation with Central Records on September 23, 2020 at 1:30 pm.

On July 22, 2020, the Texas Commission on Environmental Quality (TCEQ) received planning material for the proposed pump station. Based on our review, the project generally meets the minimum requirements of Title 30 Texas Administrative Code (TAC) Chapter 290 - <u>Rules and</u> Regulations for Public Water Systems and is **approved for construction**.

The submittal consisted of engineering drawings, technical specifications and engineering summary. The proposed project consists of:

- One 17,000 gallon AWWA D100 welded steel ground storage tank;
- One 1,700 gallon ASME welded steel pressure tank
- Two 20 horsepower booster pumps rated at 170 gallons per minute each at 243 feet total dynamic head;
- Yard piping and controls;
- Intruder resistant fencing.

This approval is for the construction of the above listed items only. Any wastewater components contained in this design were not considered. The authorization provided in this letter does not relieve a Public Water System from the need to comply with other applicable state and federal regulations.

The Possum Kingdom WSC public water system provides water treatment.

The project is located at the intersection of SH 16 and Water Ridge Rd. in Palo Pinto County.

An appointed engineer must notify the TCEQ's Region 4 Office in Dallas/Fort Worth at (817) 588-5800 when construction will start. Please keep in mind that upon completion of the water works project, the engineer or owner will notify the commission's Water Supply Division, in writing, as to its completion and attest to the fact that the completed work is substantially in accordance with the plans and change orders on file with the commission as required in 30 TAC §290.39(h)(3).

On April 8, 2013, the Texas Commission on Environmental Quality (TCEQ) received your letter dated April 3, 2013, requesting to revise a previously granted alternative capacity requirement (ACR) for the community public water system (PWS) Possum Kingdom Water Supply Corporation (WSC) under the TCEQ's requirements specified in Title 30 of the Texas Administrative Code (30 TAC) §290.45(g). In our letter dated July 30, 2002, the TCEQ (formally the Texas Natural Resource Conservation Committee) granted an alternative capacity requirement of 0.43 gallons per minute (gpm) per connection. You have requested the TCEQ to revise and modify the ACR granted on July 30, 2002 based the system's updated daily-usage data and connection count for the period of April 2010 through March 2013. The TCEQ staff reviews requests for ACRs based on an evaluation of the system's maximum daily demand and the number of actual connections served at the time. Based on our review, we are **granting** new minimum ACRs as follows:

The submitted daily usage data from April 2010 to March 2013 indicated a maximum daily demand of 1.232 million gallons per day (MGD) on August 31, 2012 with 2,396 connections for

the month of August 2012. Using the specifications in 30 TAC §290.45(g)(2), a safety factor of 1.05 was used, resulting in an equivalency ratio of 0.63.

These new minimum ACRs will replace the previous ACR values from our letter dated July 30, 2002. Please note these ACRs apply only to the Possum Kingdom WSC. They do not apply to systems that purchase water from Possum Kingdom WSC. If the purchasers wish to obtain an ACR, they will need to submit information about their systems specific water usage and connection counts.

These new minimum ACRs are contingent upon the continuing collection of daily usage data and the maintenance of these records for a minimum of three years. All minimum ACRs are subject to periodic reviews. They may be revised or revoked if water demand conditions change or if evidence is found that granting it has resulted in the degradation of potable water quality or quantity. This letter must be kept on file for as long as these ACRs are valid, and made available to TCEQ staff upon request.

Please note that the approval of these ACRs are not intended to waive compliance with any other TCEQ requirement in 30 TAC Chapter 290. This ACR cannot be used as a defense in any enforcement action resulting from noncompliance with any other requirement of 30 TAC Chapter 290.




