COMMISSION STAFF'S MOTION TO AMEND THE PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Motion to Amend the Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On August 12, 2020, Possum Kingdom Water Supply Corporation (PKWSC) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12890 in Palo Pinto County. The requested service area consists of 1,096 acres and no current connections. In response to Staff's second round of RFIs, PKWSC indicated that it intends to provide service to 170 customers in a new subdivision, Water Ridge Estates. PKWSC also indicated that Water Ridge Estates is approximately 166.85 acres.

On November 6, 2020, Order No. 3 was filed, which established a deadline of December 31, 2020 for Staff to provide final maps, certificates, and tariffs (if applicable) to PKWSC for review and consent. Therefore, this pleading is timely filed.

II. REQUEST FOR AMENDED PROCEDURAL SCHEDULE

After discussions with Staff, PKWSC has indicated its willingness to file an amended application and amended map that reduces the area requested to the Water Ridge Estates subdivision, which is the area where PKWSC has shown a need for service. Therefore, Staff proposes the following amended procedural schedule.

Event	Date
Deadline for PKWSC to amend its application and provide amended maps	January 21, 2021
Deadline for Staff to file comments on the sufficiency of PKWSC's amended application and amended maps	February 4, 2021
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to PKWSC for review and consent	March 18, 2021
Deadline for PKWSC to file signed consent forms with the Commission	April 1, 2021
If no hearing is requested, deadline for Staff to file a final recommendation on the application	April 15, 2021
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	April 29, 2021

Staff's proposed procedural schedule does not include a date for new notice. Because PKWSC is amending its application to request a smaller portion of the area that was originally noticed, and no opt out requests or motions to intervene were filed, Staff recommends that new notice should not be required.

III. CONCLUSION

For the reasons discussed above, Staff respectfully requests that the proposed procedural schedule be adopted.
