### COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF MAPPING

On August 12, 2020, Possum Kingdom Water Supply Corporation (PKWSC) filed an application to amend its water certificate of convenience and necessity (CCN) No. 12890 in Palo Pinto County. The requested service area consists of 1,096 acres and no current connections. On January 7, 2021, PKWSC filed an amended application and revised mapping and digital data to reduce the requested area to include only the Water Ridge Estates subdivision, which is the area in which PKWSC has demonstrated a need for service. The revised requested area is approximately 169 acres.

On January 4, 2021, the administrative law judge filed Order No. 4, which established a deadline of February 4, 2021 for Staff to provide comments on the sufficiency of PKWSC's amended application and amended maps. Therefore, this pleading is timely filed.

### I. SUFFICIENCY OF REVISED MAPPING

Staff has reviewed the revised mapping filed by PKWSC, and as detailed in the attached memorandum of Patricia Garcia, Infrastructure Division, Staff recommends that the revised mapping be deemed sufficient. On or before March 18, 2021, Staff will provide a final map and certificate to PKWSC for review and consent as required by the procedural schedule adopted in Order No. 4.

## II. CONCLUSION

For the reasons discussed above, Staff respectfully requests that PKWSC's revised maps be found sufficient.

Possum Kingdom Water Supply Corporation (PKWSC) filed with the Public Utility Commission of Texas (Commission) an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12890 in Palo Pinto County, Texas, under Texas Water Code (TWC) §§ 13.242 to 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237.

On January 7, 2021, PKWSC filed revised mapping and digital data to reduce the requested area to the Water Ridge Estates subdivision, which is the area PKWSC has shown to have a need for service. The requested area was reduced in size to be approximately 169 acres. Based on the mapping review by Gary Horton, Infrastructure Division, I recommend that PKWSC's revised mapping and digital data is sufficient.
