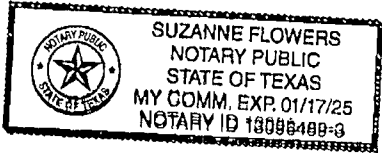

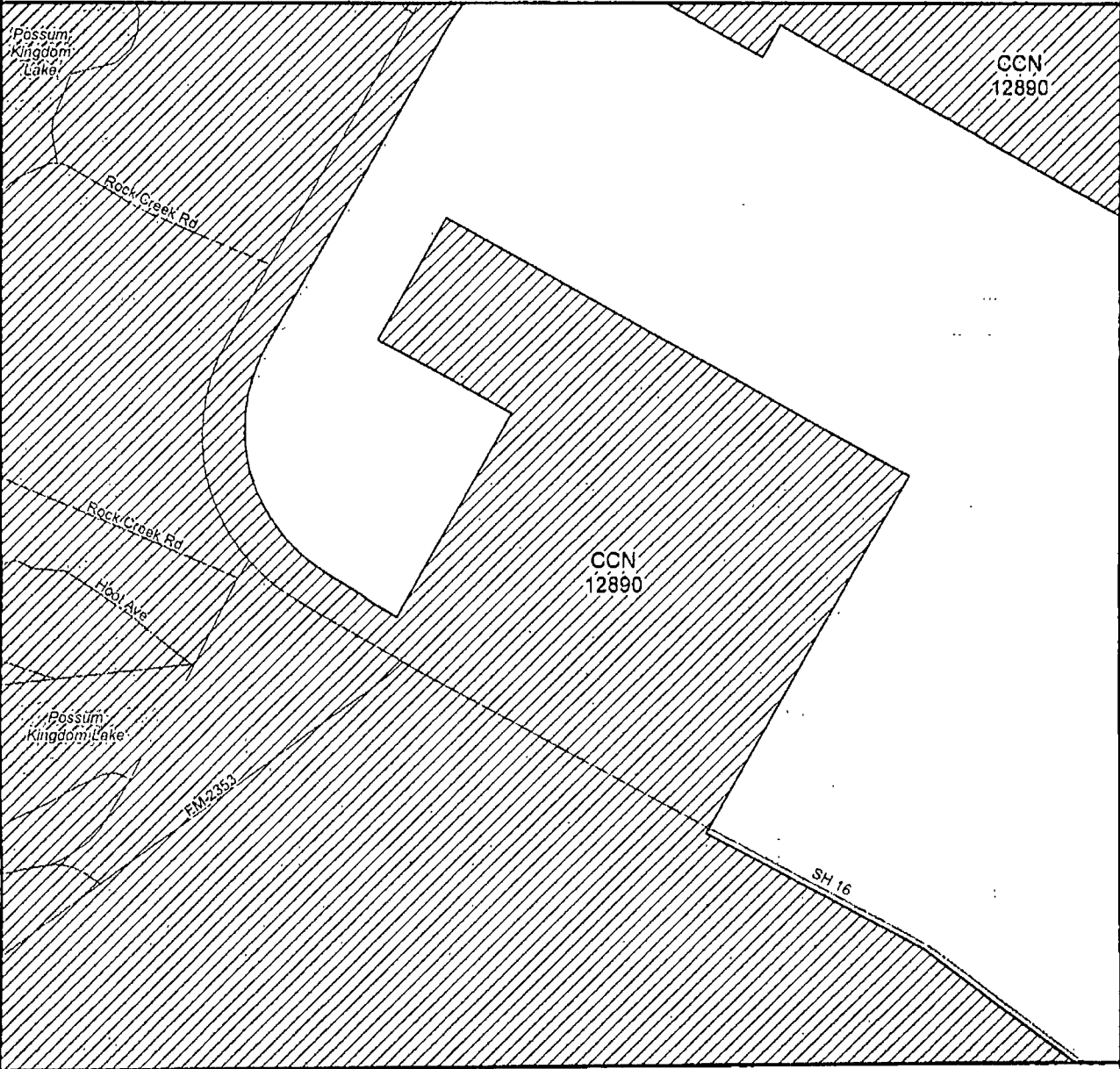

Possum Kingdom Water Supply Corporation

having obtained certification to provide water utility service for the convenience and necessity of the public, and it having been determined by this Commission that the public convenience and necessity would in fact be advanced by the provision of such service, Possum Kingdom Water Supply Corporation is entitled to this

Certificate of Convenience and Necessity No. 12890

to provide continuous and adequate water utility service to that service area or those service areas in Palo Pinto and Stephens Counties as by final Order or Orders duly entered by this Commission, which Order or Orders resulting from Docket No. 51161 are on file at the Commission offices in Austin, Texas; and are matters of official record available for public inspection; and be it known further that these presents do evidence the authority and the duty of the Possum Kingdom Water Supply Corporation to provide such utility service in accordance with the laws of this State and Rules of this Commission, subject only to any power and responsibility of this Commission to revoke or amend this Certificate in whole or in part upon a subsequent showing that the public convenience and necessity would be better served thereby.

7. On January 7, 2021, PKWSC amended its application and reduced the size of the requested water service area to 169 acres (the requested area).
 8. The original requested area is located approximately eight miles west of downtown Graford, Texas, and is generally bounded on the north by the Hills Over PK Lake Subdivision; on the east by a line approximately two miles west and parallel to Dark Valley Creek; on the south by State Highway 16; and on the west by State Highway 16.
 9. The requested area is wholly located within the boundaries of the original requested area.
10. In Order No. 5 filed on February 8, 2021, the ALJ found PKWSC's revised mapping, which reflects the 169 acres comprising the requested area, sufficient.

Notice

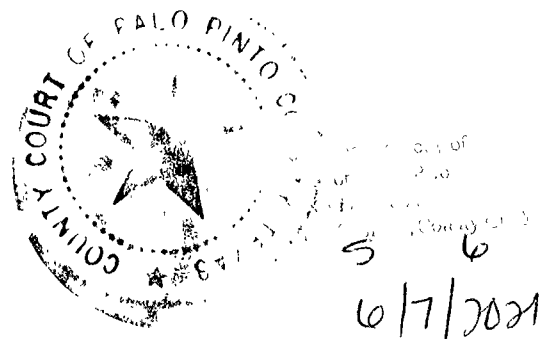
11. On October 12, 2020, PKWSC filed the affidavit of Jeremiah Gore, general manager of PKWSC, attesting that notice was mailed to neighboring utilities, county authorities, municipalities, and affected parties on September 21 and 23, 2020.
12. On October 12, 2020, PKWSC filed a publisher's affidavit attesting to the publication of notice in the *Graham Leader*, a newspaper of general circulation in Palo Pinto County, on September 19 and 26, 2020.
13. In Order No. 3 filed on November 6, 2020, the ALJ found the notice sufficient.

Map and Certificates

14. On March 18 and 24, 2021, Commission Staff emailed the proposed final map and certificate to PKWSC.
15. On March 26, 2021, PKWSC filed its consent to the proposed map and certificate.
16. On April 15, 2021, Commission Staff filed the map and certificate as attachments to its final recommendation.

Evidentiary Record

17. On April 29, 2021, the parties filed an agreed motion to admit evidence and proposed notice of approval.
18. In Order No. 6 filed on May 10, 2021, the ALJ admitted the following evidence into the record of this proceeding: (a) PKWSC's application, and all attachments, filed on August 12, 2020; (b) Commission Staff's recommendation on administrative completeness



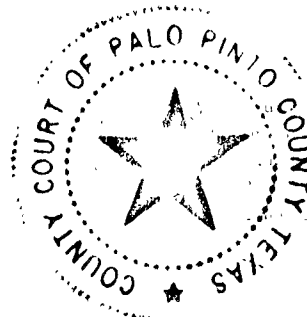
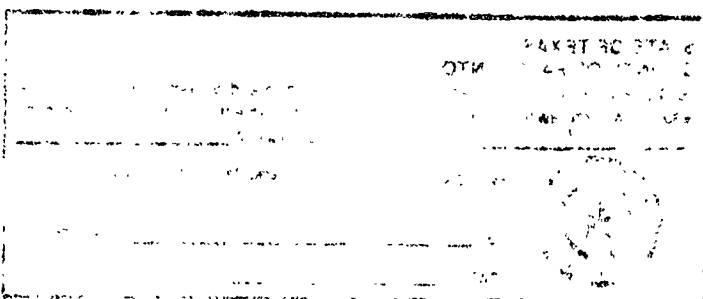
