COMMISSION STAFF'S REQUEST FOR AN EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for an Extension.

I. BACKGROUND

On August 13, 2020, Olex (United States), Inc. f/k/a Olex Corporation NV (Olex) filed a petition for streamlined expedited release of an approximately 409.11-acre tract of land within the boundaries of the Aqua Texas, Inc.'s (Aqua) water certificate of convenience and necessity (CCN) No. 13201 in Denton County, under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). Olex asserts that the tract of land is at least 25 acres, is not receiving sewer service, and is located in Denton County, which is a qualifying county. Olex filed supplemental information on October 14, 2020.

Order No. 3, filed on September 15, 2020, directed Staff to file a supplemental recommendation regarding the administrative completeness of the petition as well as a proposed procedural schedule, if appropriate, by November 13, 2020. Therefore, this pleading is timely filed.

II. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to review the supplemental information provided by Olex. Therefore, Staff respectfully requests the extension of the deadline for Staff to provide its supplemental recommendation regarding the administrative completeness of the application to November 20, 2020.

III. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request for an extension.
