ORDER NO. 6

FINDING PETITION ADMINISTRATIVELY COMPLETE AND NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the administrative completeness and notice for Colorado River Project, LLC's (CRP) petition for streamlined expedited release. On August 13, 2020 CRP filed a petition to amend SWWC Utilities, Inc. dba Hornsby Bend Utility's (Hornsby Bend) water CCN number 11978 and sewer CCN number 20650 in Travis County by expedited release. CRP filed supplemental information on August 31 and September 9, 17, and 29, 2020. CRP filed an amended petition on October 9, 2020 and a supplement to the amended petition on October 29, 2020.

I. Finding Application Administratively Complete

On November 4, 2020, Commission Staff recommended that the petition, as amended and supplemented, be found administratively complete. The administrative law judge (ALJ) finds the petition, as amended and supplemented, administratively complete.

II. Notice

CRP stated in its October 29, 2020 filing that it mailed a copy of its amended petition and supplement to the amended petition to the CCN holder, Hornsby Bend, by certified mail. The ALJ finds the notice sufficient.

III. Establishing Procedural Schedule

Under Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
