ORDER NO. 7  
 GRANTING MOTION TO AMEND PROCEDURAL SCHEDULE

This Order addresses the agreed motion to amend procedural schedule filed by SWWC Utilities, Inc. d/b/a Hornsby Bend Utility Company, Inc. (HBUC) on November 19, 2020. HBUC indicates that Commission Staff and Colorado River Project, LLC are unopposed to this motion to amend the procedural schedule.

The administrative law judge grants the motion and amends the procedural schedule as follows:

Deadline for Hornsby Bend to substantively respond to the administratively complete petition	November 30, 2020
Deadline for Commission Staff's recommendation on final disposition	December 14, 2020
Deadline for petitioner to file a reply to Hornsby Bend's response and Commission Staff's recommendation on final disposition	December 21, 2020
Sixty-day administrative approval of expedited release	January 4, 2021
<b><i>In the event expedited release is granted and the petitioner and Hornsby Bend can select an agreed-upon appraiser</i></b>	
Deadline for petitioner and Hornsby Bend to select an agreed-upon appraiser	Within 10 days after the Commission approves expedited release
Deadline for appraiser's report	Within 70 days after the Commission approves expedited
Deadline for Commission's final order determining the amount of monetary compensation, if any, owed by petitioner to Hornsby Bend	Within 60 days after appraiser's report
Deadline for petition to pay any compensation due to the Hornsby Bend	Within 90 days of Commission's final order on compensation

<i>In the event expedited release is granted and petitioner and Hornsby Bend are unable to select an agreed-upon appraiser</i>	
Deadline for reports from petitioner's appraiser and from Hornsby Bend's appraiser	Within 70 days after the Commission approves expedited release
Deadline for Commission Staff's appraiser's report	Within 100 days after the Commission approves expedited
Deadline for Commission's final order determining the amount of monetary compensation, if any, owed by petitioner to Hornsby Bend	Within 60 days after Commission receives the final appraisal
Deadline for petitioner to pay any compensation due to Hornsby Bend	Within 90 days of Commission's final order on compensation
