Dear Judge Burkhalter:

Colorado River Project, LLC ("CRP") has sought clarification of the deadline for filing the appraisals in a streamlined expedited release process. CRP notes that SWWC Utilities Inc.'s appraisal was filed on March 26. However, to be clear, CRP's valuation report was also filed on March 26.

CRP electronically filed its valuation report at 4:58 p.m. on March 25, according to the attached email received by counsel. Pursuant to 16 Tex. Admin. Code § 22.71(h), a document must be filed by 3:00 p.m. on the date due. Consequently, CRP's valuation report was filed on March 26 as well.

Because both parties have engaged experts and filed their reports on March 26, pursuant to 16 Tex. Admin. Code §§ 22.5(b) and 24.5, SWWC Utilities Inc. requests that a good cause exception be granted to 16 Tex. Admin. Code § 24.245(i)(4) and allow both parties' reports to be considered so that justice may be done.
