#### COMMISSION STAFF'S CORRECTIONS TO THE PROPOSED ORDER

On January 10, 2022, the Office of Policy and Docket Management filed a Proposed Order and Memorandum requiring the parties to file corrections or exceptions to the Proposed Order by January 25, 2022. The Staff (Staff) of the Public Utility Commission of Texas (Commission) does not intend to file exceptions to the Proposed Order. However, Staff respectfully submits the following corrections to the proposed order.

#### I. STAFF'S PROPOSED CORRECTIONS

Staff proposes the following corrections to the Proposed Order:

Modify Finding of Fact No. 40 to change the name "George Pacific" to "Georgia-Pacific," correcting a typo.

40. Sweetwater demonstrated that it has sufficient cash available to cover any projected operations and maintenance shortages in the first five years of operations after approval of the CCN amendment, satisfying the operations test. Capital improvements required to provide continuous and adequate service to the requested area will be paid for by George Pacific Georgia-Pacific and the Sweetwater Enterprise for Economic Development-Municipal Development District.

Modify Ordering Paragraph No. 4 to include the word "policies" after "water service," correcting the omission of the word "policies."

4. Sweetwater must provide service to every customer and applicant for service within the approved area under CCN number 10228 who requests water service and meets the terms of Sweetwater's water service policies, and such service must be continuous and adequate.

Modify Ordering Paragraph No. 6 to change the word "relied" to "relief," correcting a typo.

6. The Commission denies all other motions and any other requests for general or specific relief, if not expressly granted.

## II. CONCLUSION

Staff respectfully requests that the Commission adopt the corrections proposed above.
