## COMMISSION STAFF'S UNOPPOSED REQUEST FOR EXTENSION

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Unopposed Request for Extension. In support thereof, Staff shows the following:

#### I. BACKGROUND

On September 11, 2020, S.L.C. Water Supply Corporation (SLC WSC) filed an application for authority to change its water rates under Texas Water Code (TWC) §§ 13.1871 and 13.18715.

On September 18, 2020, the administrative law judge (ALJ) filed Order No. 1, directing Staff to file comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule by October 14, 2020. Therefore, this pleading is timely filed.

### II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Following discussion with Alan Hughes, President of SLC WSC's Board of Directors, it was determined that SLC WSC needs additional time to file supplemental documentation necessary for the further processing of this docket. Consequently, Staff requests that its deadline to file comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule, be extended to October 23, 2020 so that Staff and SLC WSC may continue discussions regarding what supplemental information is needed and for Staff to review the supplemental documents filed.

Staff has conferred with Mr. Hughes regarding this extension, and he has indicated SLC WSC is unopposed to the requested extension.

#### III. CONCLUSION

On the aforementioned basis, Staff respectfully requests that the ALJ extend Staff's deadline to file comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule to October 23, 2020.
