

APPLICANT'S FOURTH AND FINAL MONTHLY STATUS REPORT

COMES NOW, G & W Water Supply Corporation (G&W; Applicant), and files this Applicant's Third Monthly Status Report and respectfully show the following:

I. BACKGROUND

On September 21, 2020, Kickapoo Fresh Water Supply District (Kickapoo) and G&W Water Supply Corporation (G&W) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Waller County. The requested area includes approximately 495 acres and 50 connections (Area). Currently, the Area is dually certificated under certificate of convenience and necessity (CCN) No. 12391 held by G&W and under CCN No. 13204 held by Kickapoo.

On February 25, 2021, the Administrative Law Judge issued Order No. 6 approving the sale and authorizing the transaction between G&W and Kickapoo to proceed and be consummated. Order No. 6 requires the Applicants to file monthly updates regarding the status of the closing until the transaction is consummated.

II. FOURTH AND FINAL MONTHLY STATUS REPORT

Following Order No. 6, certain actions must be completed to consummate the transaction between G&W and Kickapoo. As of this date, Kickapoo has provided a current customer list to G&W customer deposit from Kickapoo have been addressed. Kickapoo has provided G&W with a spreadsheet showing current account balances (debits and credits). Kickapoo met on April 15, 2021, and the District was dissolved. The Final Order of Dissolution of Kickapoo Fresh Water Supply District has been recorded. A copy is attached as Exhibit A. The Utility Conveyance to the Kickapoo Preserve Community Association has been executed and recorded. A copy is attached as Exhibit B. The Bill of Sale and Assignment has been

executed and recorded. A copy is attached as Exhibit C. The Amended Information Form of Kickapoo Fresh Water Supply District of Waller County has been executed and recorded. As copy is attached as Exhibit D.

The Financing Agreement and Wholesale Water Contract has automatically terminated pursuant to the Contract for Purchase.

III. CONCLUSION AND PRAYER

The Applicants respectfully request that this Status Report be accepted and noted by the Administrative Law Judge in compliance with Order No. 6.



FINAL ORDER OF DISSOLUTION KICKAPOO FRESH WATER SUPPLY DISTRICT

WHEREAS, Kickapoo Fresh Water Supply District (the "District") was created for the purpose, among others, of providing water, sewer, drainage, and roads to the land located within its boundaries; and

WHEREAS, the Board of Directors (the "Board") has not authorized any bonds, notes, or other obligations or lent the District's credit in another form and has no other indebtedness; and

WHEREAS, the District entered into that certain Contract for Purchase dated April 29, 2020 by and between the District (the "Contract"), G&W Water Supply Corporation ("G&W"); New Waverly Sounds Investments, LLC ("New Waverly"); and Spring Preserve Water Company, LLC ("Spring Preserve"); and

WHEREAS, the Board has determined that the proposed undertaking in the District is impracticable and cannot be successfully or beneficially accomplished; and

WHEREAS, the Board has held a hearing on a proposal to dissolve the District, and all interested persons were heard at said hearing and all evidence considered; and

WHEREAS, the hearing was properly noticed as required by Section 51.782 of the Texas Water Code; and

WHEREAS, upon the dissolution of the District, the Contract provides for an automatic termination of the Financing Agreement between New Waverly and the District, as well as the Wholesale Water Contract between Spring Preserve and the District, as further described therein; and

WHEREAS, the Contract provides that all of the District's retail water facilities be conveyed to G&W upon the District's dissolution pursuant to that certain Bill of Sale and Assignment dated April 15, 2021; and

WHEREAS, the District and the Kickapoo Preserve Community Association (the "HOA") entered into the certain Utility Conveyance dated April 15, 2021 that coneys all of the District's storm sewer facilities to the HOA for ownership, operation, and maintenance upon the District's dissolution; and

WHEREAS, the Board has unanimously determined that the best interests of the persons and property in the District will be served by dissolving the District; and

WHEREAS, pursuant to Section 51.786 of the Texas Water Code, the Board appointed Harry Thompson as trustee (the "Trustee") to close out the affairs of the District; and

WHEREAS, Chapter 51, Subchapter P of the Texas Water Code authorizes the Board to dissolve the District under the above described circumstances; now, therefore

BE IT ORDERED BY THE BOARD OF DIRECTORS OF KICKAPOO FRESH WATER SUPPLY DISTRICT THAT:

- Section 1. The facts and findings recited in the preamble are found to be true and correct.
- Section 2. Harry Thompson was duly appointed as Trustee pursuant to Section 51.786 of the Texas Water Code to ensure all assets of the District have been reduced, and to apply such assets to discharge any outstanding obligations of the District.
- Section 3. The District has no remaining funds or assets requiring a distribution upon this Final Order of Dissolution. The District's retail water facilities have been conveyed to G&W by the District, and the District's storm sewer facilities have been conveyed to the HOA by the District. The District's financial assets have been conveyed in full as well. All outstanding District contracts and agreements have been terminated. Notice has been duly sent to all parties with contracts with the District of this meeting and Public Hearing.
- <u>Section 4.</u> The Trustee has ensured all assets of the District have been reduced, and applied such assets to discharge the outstanding obligations of the District. The Trustee is hereby discharged as all obligations of the District have been paid and the Trustee's account has been verified and settled.
- Section 5. Any director is authorized and directed, in the name of and on behalf of the District, to take such actions and to execute and deliver such certificates, agreements, instruments, notices and documents, or to effect any necessary filings (including, but not limited to, with the Texas Commission on Environmental Quality) with any and all appropriate regulatory authorities, state and federal, as may be required or as any such director and/or consultant may deem necessary, advisable or proper to carry out the transactions contemplated by, and the purposes and intents of, this Order. All such actions shall be performed in such manner, and all such certificates, instruments, notices and documents to be executed and delivered in such form, as the director and/or consultant performing or executing the same shall approve, the performance or execution thereof by such director and/or consultant to be conclusive evidence of the approval thereof by such director and/or consultant and by the Board.

Section 6. The District's attorneys, Allen Boone Humphries Robinson LLP, are authorized to do any and all other things necessary and proper in connection with dissolving the District.

Section 7 All actions heretofore taken by the directors of the District with respect to the foregoing are in all respects approved, confirmed and ratified.

Section 8. This Order shall be effective from and after its adoption.

Kickapoo Freshwater Supply District (the "District") has constructed certain improvements, structures, and facilities designed to provide storm sewer and/or drainage facilities to serve areas within or near the District's boundaries Kickapoo Preserve Community Aswsociation (the "HOA"). For and in consideration of the sum Ten Dollars and No/100 Dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the District does hereby convey, transfer, and deliver to the HOA, its successors and assigns, those certain facilities described as follows:

Those certain storm sewer facilities, and all related appurtenances, to serve Kickapoo Preserve, Section One (except any detention ponds) constructed to date on behalf of the District pursuant to the construction contract ("Construction Contract") between the District and Terbo Construction, L.P. ("Contractor") dated November 12, 2008, which facilities are located within or near the boundaries of the District, and together with any, structures, storm sewer mains, inlets, manholes, pipes, fittings, connection, laterals, easements, drainage swales within easements, rights-of-way, licenses, operating rights and all other property therein whether real, personal or mixed, owned by the District in connection with the facilities being conveyed hereby, as more particularly shown on Exhibit A (the "Facilities"). Some or all of the Facilities are located within or near the land shown on the plat that is recorded under 1001751 in the Official Public Records of Waller County, Texas.

The District constructed the Facilities, and is conveying the Facilities to the HOA in exchange for the HOA's continuing obligation to operate and maintain such Facilities in a good and workmanlike manner.

The District hereby assigns to the HOA all rights (including, without limitation, all rights under the Construction Contract, to the extent the Construction Contract allows assignment of such rights), owned or acquired by the District for the Facilities. Notwithstanding any provision hereof, this Utility Conveyance shall not be construed to limit or modify any indemnity obligations, or any other obligations, that Contractor, or its surety, may otherwise have to the District or to any other party under the Construction Contract. The HOA hereby agrees by its acceptance of this conveyance to own, operate, and maintain the Facilities.

This Utility Conveyance is effective as of the later of: (i) the date that the District executes this instrument; or (ii) the date that the HOA executes this instrument.



Kickapoo Freshwater Supply Distric, a water conservation and improvement district organized and empowered under Article XVI, Section 59 of the Texas Constitution and governed by Chapter 51 of the Texas Water Code ("Grantor"), for and in consideration of the sum of ten and no/100 dollars (\$10.00) cash and other good and valuable consideration paid to Grantor by G & W Water Supply Corporation, a Texas non-profit water supply corporation ("Grantee"), the receipt and sufficiency of which is hereby acknowledged, hereby grants, sells, assigns, and conveys unto Grantee, those assets associated with Grantor's water facilities (the "Water Facilities"), such assets described as follows:

- 1. Real or Personal Property: Those certain water facilities, and all related appurtenances, to serve Kickapoo Preserve, Section One (except any detention ponds, any storm sewer facilities, any drainage channels, and any non-potable water facilities) constructed to date on behalf of the District pursuant to the construction contract between the District and Terbo Construction, L.P. dated November 12, 2008, which facilities are located within or near the boundaries of the District, and together with any distribution lines, collection lines, water mains, water meters, valves, pipes, fittings, fire hydrants, flushing valves, connections, meter boxes, water services, easements, rights-of-way, licenses, operating rights and all other property therein whether real, personal or mixed, owned by the District in connection with the facilities being conveyed hereby, as more particularly shown on Exhibit A. Some or all of the Water Facilities are located within or near the land shown on the plat that is recorded under 1001751 in the Official Public Records of Waller County, Texas.
- 2. <u>Property Agreements</u>: all of Grantor's right, title, and interests, to the extent Grantor's interests are assignable, in and to any pipeline easements, water line easements, sanitary control easements, public utility easements, and all ingress/egress easements to utility facilities,

to the extent such easements exist, and are associated with the Water Facilities.

3. <u>Intangibles and Other Miscellaneous Rights</u>: all of Grantor's right, title, and interest in and to all (i) plans, models, drawings, specifications, surveys, engineering reports, and other technical descriptions or materials that are in the possession of Grantor or its representatives (the "Plans"); (ii) licenses, permits, franchises, and similar rights issued by any federal, state, or local authority and associated with the Water Facilities (the "Permits"); and (iii) all other rights associated with the Water Facilities (the "Intangibles").


