## ORDER NO. 11 REQUESTING RESPONSE

This Order addresses Commission Staff's August 13, 2021 recommendation on further processing of the application and motion to restyle. Commission Staff stated they have determined that processing this application as a sale, transfer, or merger is not necessary as prescribed under 16 Texas Administrative Code (TAC) § 24.239. Further, Commission Staff recommended that this application would be more appropriately reviewed and considered under 16 TAC § 24.249, which addresses the cessation of operations by a retail public utility. Commission Staff also requested restyling of this docket to reflect the above change.

After review of the recommendation, the administrative law judge requests that the applicants file a response to Commission Staff's recommendation, and specifically address the effective date required by 16 TAC § 24.249(a)(2), on or before August 26, 2021. Restyling of the docket, if deemed appropriate, will be considered in a future order.
