## **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On September 23, 2021the City of Hempstead (Hempstead) and G&W Water Supply Corporation (G&W WSC) (collectively, Applicants) filed an application with the Staff (Staff) of the Public Utility Commission (Commission) (collectively, the Parties) for the sale, transfer, or merger (STM) of facilities and certificate rights in Waller County, Texas. The area includes approximately 120 acres and 0 connections.

On August 24, 2021, the administrative law judge (ALJ) Filed Order No. 12, restyling the docket an requiring the Parties to file a joint motion to admit evidence and proposed order, findings of fact, and conclusions of law on or before October 18, 2021. Therefore, this pleading is timely filed.

## I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. The Parties require additional time to collect the requisite signatures for their joint filing. Therefore, the Parties respectfully request that the deadline to file a joint motion to admit evidence and proposed order, findings of fact, and conclusions of law be extended until October 25, 2021.

Staff respectfully requests the issuance of an order extending the deadline for the Parties to file a joint motion to admit evidence and proposed order, findings of fact, and conclusions of law be extended until October 25, 2021.
