WEST WISE SUD'S NOTICE OF NON-RECEIPT OF SIGNED CCN AND FINAL MAP AND MOTION FOR EXTENSION OF TIME

On December 23, 2020, West Wise Special Utility District ("West Wise SUD") received by mail the Order dated December 17, 2020, signed by the Public Utility Commissioners releasing the 31.119-acre tract of land identified in the petition of Destiny Development, LLC, as the agent for Ms. Cyd Bailey, for streamlined expedited release from West Wise' service area under Certificate of Convenience and Necessity ("CCN") number 10284. Conclusion of Law No. 18 of the Order states that the CCN holder is required to record certified copies of the approved CCN and map, along with the boundary description of the service area, in the real property records of Wise County no later than the 31st day after the date the CCN holder <u>receives the Order</u>.

The certified copies of the approved CCN and map were not attached to the Order signed on December 17, 2020, received by West Wise on December 23, 2020, and to date, despite numerous inquiries to PUC Staff, the documents have not been received. The signed CCN and final map have also not been filed with the PUC Interchange.

Therefore, West Wise respectfully requests: 1) <u>an extension of time</u> to file in the real property records the certified copies of the approved certificate and maps until 31 days after those documents are received by West Wise (See, COL 18); and 2) <u>an extension of time</u> to file in this
