## WEST WISE SPECIAL UTILITY DISTRICT'S MOTION TO INTERVENE

West Wise Special Utility District ("West Wise SUD") files this Motion to Intervene as a party to the above-captioned proceeding. In support of its Motion, West Wise SUD shows as follows:

- 1. Destiny Development, LLC filed a petition to amend West Wise SUD's Water Certificate of Convenience and Necessity ("CCN") No. 10284 in Wise County by expedited release on September 26, 2020. West Wise SUD is the current CCN holder for the subject tracts. Thus, West Wise SUD has a justiciable interest that may be adversely affected by the outcome of this proceeding, specifically the loss of its certificated service rights and the potential for stranded capacity in its existing utility infrastructure.
