The Commission is scheduled to consider the Proposed Order in this docket at an open meeting currently scheduled to begin at 9:30 a.m. on Wednesday, April 7, 2021, at the Commission's offices, 1701 North Congress Avenue, Austin, Texas. On March 10, 2021, a proposed order was issued in this case. The accompanying memorandum stated that the parties had until March 25, 2021 to file corrections or exceptions. On March 25, 2021, Intervenor G&W Water Supply Company filed exceptions and proposed corrections to the order.

The ALJ has carefully studied and considered G&W's arguments and proposed findings of fact, conclusions of law, and ordering paragraphs. The ALJ rejects the intervenor's interpretation of the standards set forth for receiving service set forth in the *Crystal Clear¹* decision, as well as Intervenor's jurisdictional argument, and declines to adopt any of the Intervenor's proposed language listed in its Intervenor Utility's Exceptions to Proposed Order.
