# REQUEST FOR ORDER ON COMPENSATION AMOUNT

COMES NOW, G & W Water Supply Corporation ("G & W") and files this Request for Order on Compensation Amount under 16 Texas Administrative Code section 24.245(i)(5) and in support shows the following:

### I. BACKGROUND INFORMATION

On October 7, 2020, RCR Hempstead Rail, LP, filed with the Public Utility Commission ("PUC") a petition for a streamlined expedited release of a portion of G & W's water CCN 12391 service area.

On November 2, 2020, G&W filed a motion to intervene and notice of appearance. The motion was granted on January 12, 2021 in Order No. 4.

The Commission granted the Petitioner's petition in an order dated April 7, 2021. Pursuant to that order, which incorporates by reference the Administrative Law Judge's Order No. 3 schedule, this case is now in the compensation award stage under 16 Texas Administrative Code section 24.245(i) and (j).

On May 12, 2021, G & W and RCR Hempstead Rail, L.P. filed a Joint Notice of Compensation Settlement.

#### II. REQUEST FOR ORDER ON COMPENSATION AMOUNT

G & W and Petitioner have reached a settlement on the amount of compensation to be paid by Petitioner to G & W in this matter. The final step in closing this Docket is the issuance of a Compensation Order under 16 Texas Administrative Code section 24.245(i)(5). This will enable payment of compensation to G & W by RCR Hempstead Rail, L.P. under their settlement agreement.

WHEREFORE, PREMISES CONSIDERED, G & W respectfully requests: (i) the agreed upon compensation of \$20,000.00 be approved; (ii) as required by 16 Texas Administrative Code section 24.245(i)(6), RCR Hempstead Rail, L.P. be ordered to pay this compensation to G & W not later than 90 days after the final order; (iii) and all further relief provided under equity and law.
