APPLICATION OF DOS AGUAS, LLC FOR A WATER CERTIFICATE **OF CONVENIENCE AND NECESSITY IN WALKER AND MONTGOMERY COUNTIES**

PUBLIC UTILITY COMMISSION

COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS, NOTICE, AND PROPOSED PROCEDURAL **SCHEDULE**

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Supplemental Recommendation on Administrative Completeness, Notice, and Proposed Procedural Schedule. Staff recommends that the application is administratively complete. In support thereof, Staff would show the following:

I. BACKGROUND

On October 9, 2020, Dos Aguas, LLC (Dos Aguas) filed an application to obtain a water certificate of convenience and necessity (CCN) in Walker and Montgomery counties. The requested service area consists of approximately 5,386 acres to be developed into 292 one-acre lots in Walker County and 1,800 to 1,900 one and one-half to two acre-lots in Montgomery County. Dos Aguas filed supplemental information on October 21, 2020, October 29, 2020, November 10, 2020, November 19, 2020, December 1, 2020, and December 3, 2020.

On November 10, 2020, Order No. 2 in this proceeding was filed, requiring Staff to file a supplemental recommendation on the administrative completeness of the application and proposed notice and to propose a procedural schedule by January 18, 2021. Therefore, this pleading is timely filed.1

II. **ADMINISTRATIVE COMPLETENESS**

Staff has reviewed Dos Aguas' supplemented application and, as detailed in the attached memoranda from Patricia Garcia, Infrastructure Division, and Fred Bednarski, Rate Regulation

Division,² recommends that the application is now administratively complete. Staff does not comment on the merits of the application at this time.

III. NOTICE

At this time, Staff recommends that Dos Aguas use the attached notice forms to proceed with providing public notice to all neighboring utilities, affected customers, landowners of a tract of 25 acres or more, political subdivisions, and other entities listed in Ms. Garcia's attached memorandum. Along with each individual notice, Staff recommends that Dos Aguas provide an accurate map delineating the requested service area. Staff also recommends that Dos Aguas use the attached Notice for Publication to publish notice once each week for two consecutive weeks in a newspaper of general circulation in both Walker and Montgomery counties.

Upon completion of notice, Staff recommends that Dos Aguas file proof of notice as described in Ms. Garcia's memorandum and using the attached affidavits.

IV. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule for the continued processing of this application:

Dos Aguas, LLC (Dos Aguas) filed with the Public Utility Commission of Texas (Commission) an application for a water certificate of convenience and necessity (CCN) in Montgomery, San Jacinto, and Walker Counties, Texas under Texas Water Code (TWC) §§ 13.242 to 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237.

Convenience and Necessity in Walker and Montgomery County

Based on the mapping review by Gary Horton, Infrastructure Division, the financial and managerial review by Fred Bednarski, III, Rate Regulation Division, and my technical and managerial review of the additional information filed by Dos Aguas on November 10 and 11, 2020 and December 12 and 13, 2020, I recommend that the application be deemed administratively complete. I further recommend Dos Aguas be ordered to do the following:

- 1) Provide notice of the application by first-class mail to the following:
 - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:
 - C & R Water Supply Inc (CCN No. 13098)
 - Crystal Springs Water Company Inc (CCN No. 11373)
 - Domestic Water Company (CCN No. 10348)
 - Montgomery County Municipal Utility District 38
 - One Five O Water Supply Corporation (CCN No. 12339)
 - Quadvest LP (CCN No. 11612)
 - San Jacinto River Authority
 - *T & W Water Service Company (CCN No. 12892)*
 - b. The county judge of each county that is wholly or partially included in the requested area:

- Montgomery County Judge
- San Jacinto County Judge
- Walker County Judge
- c. Each groundwater conservation district that is wholly or partially included in the requested area:
 - Bluebonnet Groundwater Conservation District
 - Lone Star Groundwater Conservation District
 - Lower Trinity Groundwater Conservation District
- d. Each landowner of a tract of land that is at least 25 acres and is wholly or partly located in the requested area. Notice must be mailed to the owner of the tract of land according to the most current tax appraisal rolls of the applicable central appraisal district at the time the application was filed.
- e. Any affected customers, and other affected parties in the requested area.

Addresses can be obtained by Dos Aguas from the Water Utility Database at <u>http://www.puc.texas.gov/watersearch</u>. District information and addresses can be obtained from the Texas Commission on Environmental Quality's (TCEQ) web site located at <u>http://www14.tceq.texas.gov/iwud/.</u>

- 2) Publish notice in a newspaper having general circulation in each county where the requested area is located, once each week for two consecutive weeks. Proof in the form of a publisher's affidavit must be filed within 30 days of the publication date. The affidavit must state with specificity each county in which the newspaper is of general circulation. Within 30 days of the date the notice was mailed, Dos Aguas must file an affidavit specifying the notice that was provided to every person and entity to whom notice was provided and the date the notice was mailed.
- 3) Provide notice using the attached notice forms.
- 4) Provide a copy of the map(s) deemed sufficient during administrative review delineating the requested area with each individual notice to neighboring utilities, other affected parties, landowners and customers.
- 5) File in the docket copy of notice and the map(s) deemed sufficient during administrative review along with the signed affidavit specifying every person and entity to whom notice was provided, the date that the notice was provided, and the publisher's affidavit and tear sheets for proof of newspaper publication.
- 6) Supplement the application with a copy of the approval letter for the plans and specifications for the water plant facilities and distribution system from TCEQ once it is received. Dos Aguas must file the approval letter(s) prior to Staff making a final recommendation on the application.

Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed, Staff may send requests for information (RFI) to Dos Aguas. Dos Aguas will have 20 days from the receipt of the RFI to respond.

On October 9, 2020 Dos Aguas, LLC filed an application to obtain a water certificate of convenience and necessity in Walker and Montgomery Counties under the provisions of Texas Water Code §§ 13.242 to 13.250 and 16 Texas Administrative Code §§ 24.225 to 24.237.

I reviewed the answers provided to questions 30 and 31 of the application and did not identify any deficiencies in those answers for purposes of determining whether the application is administratively complete. Therefore, I recommend that the application be deemed administratively complete from a financial perspective.
