





APPLICATION OF DOS AGUAS, LLC FOR A WATER CERTIFICATE OF CONVENIENCE AND NECESSITY IN WALKER AND MONTGOMERY COUNTIES

ORDER NO. 4 FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the notice provided by Dos Aguas, LLC. On April 1, 2021, Commission Staff filed a recommendation regarding the notice provided.

On March 1, 2021, Dos Aguas filed the following: (1) the affidavits of Scott Rohe, Dos Aguas' president, attesting that notice of the application was mailed to landowners, neighboring utilities, county officials, and affected parties on January 28, 2021; (2) a publisher's affidavit attesting to the publication of notice of the application in the *Montgomery County News*, a newspaper of general circulation in Montgomery County, on February 3 and 10, 2021; and (3) a publisher's affidavit attesting to the publication of notice of the application in the *San Jacinto News Times*, a newspaper of general circulation in San Jacinto County on February 4 and 11, 2021. On March 23, 2021, Dos Aguas filed the following: (1) the affidavits of Mr. Rohe attesting that notice of the application was mailed to landowners, neighboring utilities, county officials, and affected parties on March 22, 2021; and (b) a publisher's affidavit attesting to the publication of notice of the application in the *Huntsville Item*, a newspaper of general circulation in Walker County, on February 4 and 11, 2021. Representative copies of the notice and maps were attached to Dos Aguas' March 1, 2021 and March 23, 2021 filings.

The administrative law judge finds the notice sufficient and in compliance with the requirements in 16 Texas Administrative Code § 24.235(a) through (c).

The following procedural schedule is established for continued processing of this docket:
