COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

On October 9, 2020, Dos Aguas, LLC (Dos Aguas) filed an application with the Public Utility Commission of Texas (Commission) to obtain a water certificate of convenience and necessity (CCN) in Walker and Montgomery counties.

On April 25, 2022, the administrative law judge issued Order No. 9, directing the Staff (Staff) of the Commission to file a proposed procedural schedule by June 1, 2022. Therefore, this pleading is timely filed.

I. PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule for further processing of the docket:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Dos Aguas for review and consent	July 11, 2022
Deadline for Dos Aguas to file signed consent forms with the Commission	July 18, 2022
If no hearing is requested, deadline for Staff to file a final recommendation on the application	August 1, 2022
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusion of law	August 12, 2022

Staff has conferred with counsel for Dos Aguas and is authorized to represent it is unopposed to the proposed procedural schedule.

II. CONCLUSION

Staff respectfully recommends that the proposed procedural schedule above be adopted for the continued processing of this matter.
