**DOS AGUAS, LLC NOTICE OF NO CORRECTIONS OR EXCEPTIONS TO THE
REVISED PROPOSED DRAFT ORDER**

On October 9, 2020, Dos Aguas, LLC (Dos Aguas) filed an application with the Commission to obtain a water certificate of convenience and necessity (CCN) in Walker, San Jacinto, and Montgomery counties. On May 27, 2022, Dos Aguas filed an amended application which reduced the requested service area to 2,753 acres. On August 1, 2022, Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) recommended that the application be approved.

On September 13, 2022, the Administrative Law Judge (“ALJ”) filed its Revised Proposed Order, requiring parties to propose corrections or exceptions by September 27, 2022.

I. NOTICE OF NO PROPOSED CORRECTIONS OR EXCEPTIONS


Dos Aguas sincerely appreciates the Commission ALJ’s expeditious review of the additional evidence and the drafting of the Revised Proposed Order. Dos Aguas also appreciates Commission Staff’s assistance finalizing this case and Staff’s diligent review of the Revised Proposed Order. Dos Aguas and Staff have no corrections or exceptions to the Revised Proposed Order.¹ Although the ALJ memo accompanying the Revised Proposed Order indicates no response is necessary if there are no corrections or exceptions, Dos Aguas makes this filing early to alert the ALJ and permit expeditious processing of this case.

Dos Aguas is currently not charging for the water usage it is providing, which is amounting to in excess of \$13,500 per month. This monthly amount is anticipated to increase until a final order may be issued in this case. Dos Aguas therefore respectfully requests that this case continue to be processed as expeditiously as possible and placed on the earliest open meeting that may be permitted.
