**ORDER NO. 2
FINDING PETITION ADMINISTRATIVELY COMPLETE AND NOTICE
SUFFICIENT; AND ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the October 16, 2020, petition of West Bastrop Village, Ltd. to amend Aqua Water Supply Corporation's water certificate of convenience and necessity (CCN) No. 10294 in Bastrop County by streamlined expedited release, and the sufficiency of the petition and notice.

On November 16, 2020, Commission Staff filed its recommendation regarding the sufficiency of the petition and notice.

The administrative law judge (ALJ) finds the petition administratively complete and notice sufficient.

Under the provisions of Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, if streamlined expedited release is approved, the docket will continue for the purpose of determining the issue of compensation.

The ALJ establishes the following procedural schedule applies in this case:

Sixty-day administrative approval of expedited release	February 8, 2021 ¹
<i>In the event expedited release is granted and the petitioner and CCN Holder can select an agreed-upon appraiser</i>	
Deadline for petitioner and CCN Holder to select an agreed-upon appraiser	Within 10 days after the Commission approves expedited release
Deadline for appraiser's report	Within 70 days after the Commission approves streamlined expedited release
Deadline for Commission's final order determining the amount of monetary compensation, if any, owed by the petitioner to CCN Holder	Within 60 days after appraiser's report
Deadline for the petitioner to pay any compensation due to CCN Holder	Within 90 days of Commission's final order on compensation
<i>In the event expedited release is granted and petitioner and CCN Holder are unable to select an agreed-upon appraiser</i>	
Deadline for reports from the petitioner's appraiser and from CCN Holder's appraiser	Within 70 days after the Commission approves expedited release
Deadline for Commission Staff's appraiser's report	Within 100 days after the Commission approves streamlined expedited release
Deadline for Commission's final order determining the amount of monetary compensation, if any, owed by the petitioner to CCN Holder	Within 60 days after Commission receives the final appraisal
Deadline for the petitioner to pay any compensation due to CCN Holder	Within 90 days of Commission's final order on compensation

¹ 60 days from the date of finding the application administratively complete (December 8, 2020) is Sunday, February 7, 2021. Therefore, the deadline advances to the next business day, Monday, February 8, 2021, under 16 Texas Administrative Code § 22.4(a)
