## **COMMISSION STAFF'S REQUEST FOR EXTENSION**

**IN HARRIS COUNTY** 

On November 15, 2019, Quadvest, L.P. (Quadvest) filed an application in docket no. 50244 to amend its certificates of convenience and necessity (CCN) in Harris County. Quadvest holds water CCN number 11612 and sewer CCN number 20952. The requested service area consists of approximately 50 acres and has 0 current customers. On November 3,2020, the administrative law judge (ALJ) filed Order No. 1 granting Quadvest's request to sever the water and sewer portions of its application. Accordingly, this docket addresses the sewer portion of Quadvest's application.

In Order No. 8, filed on April 14, 2021, the ALJ directed Staff of the Public Utility Commission of Texas (Commission) to file comments addressing Quadvest's February 19, 2021 filing by May 12, 2021. Therefore, this pleading is timely filed.

#### I. **REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is working on an agreement with Quadvest regarding the status of their Texas Pollutant Discharge Elimination System (TPDES) permit. Accordingly, Staff requests that its deadline to request a hearing or to file a response to Quadvest's February 19, 2021 filing be extended to June 14, 2021.
