COMMISSION STAFF’S MOTION TO WITHDRAW STAFF’S AMENDED TARIFFS

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Motion to Withdraw Staff’s Amended Tariffs. In support thereof, Staff shows the following:

I. BACKGROUND

On October 16, 2020, Blessing Mobile Home Park (Blessing Mobile), certificate of convenience and necessity Nos. (CCN) 11986 and 20653, filed an application to implement a pass-through rate change under 16 Texas Administrative Code (TAC) § 24.25(b)(2)(F) for an increase in the cost of purchased water and purchased wastewater treatment from the City of Round Rock (the City). The cost of purchased water rose from \$1.90 per 1,000 gallons in 2013 to \$2.39 per 1,000 gallons and the cost of purchased wastewater treatment rose from \$3.60 per 1,000 gallons in 2013 to \$3.90 per 1,000 gallons. Effective December 1, 2020, Blessing Mobile has requested a water pass-through rate change from \$2.88 per 1,000 gallons to \$3.45 per 1,000 gallons and a wastewater pass-through rate change from \$4.15 per 1,000 gallons to \$4.45 per 1,000 gallons.

On December 14, 2020, based on the November 17, 2020 notice filed by the administrative law judge, Blessing Mobile and Staff jointly filed findings of fact and conclusions of law. Staff also filed Staff’s Amended Tariff, but as explained below, Staff withdraws its Amended Tariff.

II. REQUEST TO WITHDRAW STAFF’S AMENDED TARIFFS

Staff respectfully withdraws the amended water and sewer tariffs filed on December 14, 2020. Staff filed the amended tariffs to correct what Staff believed was an error in the water pass-through rate of \$2.81 per 1,000 gallons and the sewer pass-through rate of \$3.90 per 1,000 gallons listed in the tariffs attached to Staff’s final recommendation. Upon further discussion, Staff has confirmed that the tariffs filed on November 16, 2020 are correct because the water rate of \$3.45 per 1,000 gallons recommended by Staff is the pass-through rate of \$2.81 plus the base gallonage rate of \$0.64 per 1,000 gallons. Similarly, the sewer rate of \$4.45 recommended by Staff is the

pass-through rate of \$3.90 plus the base gallonage rate of \$0.55 per 1,000 gallons. Therefore, Staff requests to withdraw the amended tariffs filed on December 14, 2020.

III. CONCLUSION

For the reasons discussed above, Staff respectfully withdraws its amended tariffs.
