



**STAFF RFI 1-1** Please provide the docket number(s) where SW Water Area 1 and SW Water Area 2, listed in the proposed tariff for Aqua Texas, Inc., were added to the tariff and the public water system numbers for each of these systems.

**RESPONSE:** SW Water Area 1 and SW Water Area 2 were added to Aqua Texas, Inc.'s tariff in PUC Docket No. 48769. However, the areas were certificated to Aqua Development, Inc., CCN No. 12902, for many years prior even though not identified as SW Water Area 1 and SW Water Area 2. Those identifiers were assigned as part of the PUC Docket No. 48769 application process for notice purposes. There are no facilities or customers in those areas and no corresponding public water system numbers.

**STAFF RFI 1-3** Please provide a list of all affiliated organizations and explain the affiliate's business relationship with the applicant.

**RESPONSE:** Aqua Utilities, Inc., Aqua Development, Inc., Harper Water Company, Inc., and Kerrville South Water Company, Inc. are all business organizations that are or were previously regulated by the Public Utility Commission of Texas and TCEQ. They are all owned by Essential Utilities, Inc. (formerly known as Aqua America, Inc.) as is Aqua Texas, Inc. All previously operated together under the assumed name of Aqua Texas, but Aqua Development, Inc., Harper Water Company, Inc. and Kerrville South Water Company, Inc. have now transferred their assets and CCN service areas to Aqua Texas, Inc. with PUC approval. Aqua Utilities, Inc. still holds some water and wastewater facilities and CCN service areas, but it has transferred most of its facilities and CCN service areas to Aqua Texas, Inc. with PUC approval.

Another Texas business organization owned by Essential Utilities, Inc. is called Aqua Operations, Inc. That entity does not perform functions regulated by the Public Utility Commission of Texas.
