



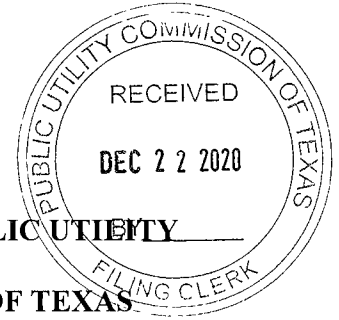

**AQUA'S REQUEST FOR EXTENSION OF DEADLINE**

COME NOW Applicants Aqua Utilities, Inc. and Aqua Texas, Inc. ("Aqua") and file this Request for Extension of Deadline to file the notice affidavits as instructed in Order No. 2 issued in this docket on November 24, 2020 ("Order").<sup>1</sup> In support, Aqua respectfully shows the following.

The Order established a deadline of December 27, 2020 for Aqua to file with the Commission signed affidavits that the notice was given along with a copy of the notice sent to the affected parties. On December 10, 2020, Aqua mailed notices to its customers and required neighboring utilities and districts. On December 16, 2020, and December 23, 2020, the Commission provided notice either was or will be published in The Bandera Bulletin. However, with the intervening holidays, Aqua is uncertain whether the publisher's affidavit from The Bandera Bulletin will be received in time to file it by December 27, 2020.

Therefore, Aqua respectfully requests an extension until January 4, 2021 to file the required affidavits of notice.

**Conclusion**




