ORDER NO. 4 FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE FOR CONTINUED PROCESSING

This Order addresses the administrative completeness of the application filed by Aqua Utilities, Inc. and Aqua Texas, Inc. on October 22, 2020. The applicants filed supplemental documentation on November 10, 17, and December 28, 2020.

This Order addresses the sufficiency of the notice provided by Aqua Utilities, Inc. and Aqua Texas, Inc. regarding the sale, transfer, or merger of facilities and certificate rights in Victoria County. On February 22, 2021 and March 2, 2021, the applicants filed affidavits attesting to the provision of notice of the application to the affected parties on January 29, 2021. Representative copies of the notice and map were attached to the affidavits.

The administrative law judge (ALJ) finds the notice sufficient.

The following procedural schedule applies for continued processing:

¹ Under 16 TAC § 24.239(b), the intervention period shall not be less than 30 days unless good cause is shown. Notice was mailed on January 29, 2021. Therefore, 30 days after January 29, 2021 is February 28, 2021. February 28, 2021 falls on a Sunday, which pushes the intervention deadline to March 1, 2021 under 16 TAC § 22.4(a).

Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed.	April 19, 2021
120-day deadline for the Commission to approve the sale or require a hearing	May 3, 2021 ²

² Under 16 TAC § 24.239(a) and (i), the deadline for Commission action is 120 days after the mailing or publication of notice, whichever occurs later. One hundred and twenty days after January 29, 2021 is May 29, 2021. Because May 29, 2021 falls on a Saturday, the deadline for Commission action is Monday, May 31, 2021 under 16 TAC § 22.4(a).
