The area is located in Victoria County, Texas. The portion of water and/or sewer service area(s) transferred to Aqua Texas' CCN(s) is described as follows. Aqua Texas' transferred areas are depicted in the attached PUC certified maps.

The requested area is located approximately 5 miles east-northeast of downtown Victoria, Texas, and is generally bounded on the north by US 59 Business; on the east by Holt Road; on the south by US 59; and on the west by Burroughsville Road. The total requested area includes approximately 174 acres and 75 current customers.

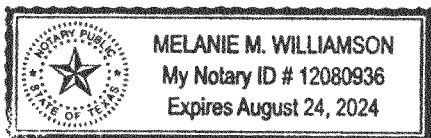

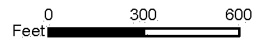
