EL PASO ELECTRIC COMPANY'S RESPONSE TO OPDM MEMO REGARDING EVIDENTIARY ISSUES AND MOTION TO ADMIT ADDITIONAL EVIDENCE

El Paso Electric Company ("EPE" or "the Company") files this Response to the March 8, 2022, Memo of the Commission's Office of Policy and Docket Management ("OPDM") Regarding Evidentiary Issues along with a Motion to Admit Additional Evidence and would respectfully show as follows:

On March 8, 2022, OPDM filed a memorandum requesting that EPE address the following issues:

Evidence Regarding Intervenor Maps

OPDM request: "Please identify the location in the evidentiary record of the map or maps reflecting the location of the current intervenors' tracts of land relative to the filed route segments. OPDM requests responses to this issue by Friday, March 18, 2022, at 3:00 PM.

If a full-sized map or maps reflecting the location of the current intervenors' tracts of land relative to the filed route segments is not in the evidence, please file and seek the admission of such evidence."

EPE Response: EPE did not previously file maps reflecting the location of the current intervenors' tracts of land relative to the filed route segments. EPE is attaching to this pleading, as Supplemental Maps Attachment A, maps reflecting such locations including a single overall map of the study area and four close-up maps of the areas around the intervenors' tracts of land.

Conclusion and Motion to Admit Evidence

EPE appreciates the opportunity to provide the requested intervenor maps in this docket. EPE will be glad to provide any further information or clarification that would be needed or useful for the processing of the Company's application in this docket.
