#### Response:

The repairs performed by CSWR-Texas Utility Operating Company LLC ("CSWR Texas" or the "Company") on 10/1/2020 to remedy the overflowing septic system was a one-time repair due to the state of the system.

CSWR Texas will pump the septic tank quarterly. However, CSWR has determined that because the septic system is under-designed, there will be higher costs for pumping the septic tank going forward. CSWR Texas estimates that the quarterly cost of the pumping will range from approximately \$2,200-\$2,500 rather than the \$1,680 charged for the initial pumping.

CSWR Texas anticipates that it will need to perform a jetting of the collection line only once every five years.
