COMMISSION STAFF'S REQUEST FOR EXTENSION

On November 4, 2020, Chester Maples dba Old Highway 90 Water Service (Old Highway 90) filed an application to amend water Certificate of Convenience and Necessity (CCN) number 12975 in Medina and Frio counties. The amendment proposes to add 994 acres to old Highway 90's service area.

On June 30, 2021, the administrative law judge (ALJ) filed Order No. 9, which granted Yancey Water Supply Corporation's (YWSC) motion to intervene, and on July 13, 2021, the ALJ filed Order No. 10, which overruled Old Highway 90's objection to YWSC's intervention.

On July 15, 2021, the ALJ filed Order No. 11, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates and tariffs to Old Highway 90 by August 6, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On July 30, 2021, YWSC filed its response to Order No. 11, stating that it intended to file a request for a hearing by the deadline established by Order No. 11. Further, contemporaneously with this request for extension, Staff is filing its third set of requests for information (RFIs), and Old Highway 90's responses are necessary for Staff to develop the final maps. Therefore, in order to allow sufficient time for Old Highway 90 to respond and for Staff develop final maps in accordance with Old Highway 90's response, Staff respectfully requests an extension of time until October 1, 2021 to provide final maps, certificates and tariffs to Old Highway 90.

II. CONCLUSION

Staff respectfully requests the issuance of an order extending the deadline for Staff provide final maps, certificates and tariffs to Old Highway 90 until October 1, 2021.
