COMMISSION STAFF’S REQUEST FOR PREHEARING CONFERENCE

On November 4, 2020, Chester Maples dba Old Highway 90 Water Service (Old Highway 90) filed an application to amend its water Certificate of Convenience and Necessity (CCN) number 12975 in Medina and Frio counties. On August 13, 2021, Yancey Water Supply Corporation (YWSC), a Texas retail public utility and nonprofit water supply corporation, filed a request for a hearing and requested referral to the State Office of Administrative Hearings (SOAH). On September 23, 2021, the Office of Policy and Docket Management filed an Order of Referral.

On September 1, 2022, the SOAH ALJ filed SOAH Order No. 3 establishing a deadline for either an agreed procedural schedule or a request for prehearing conference by September 15, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR PREHEARING CONFERENCE

While the parties have conferred on a potential procedural schedule for this docket, the parties have yet to come to an agreement on the proposed schedule. As there is not an agreed schedule at this time, Staff respectfully request a prehearing conference be set for this case.
