**ORDER NO. 1
REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS, PROPOSED
NOTICE, PROPOSED PROCEDURAL SCHEDULE, AND ADDRESSING OTHER
PROCEDURAL MATTERS**

This Order addresses the November 5, 2020 application of Jacobia Water Supply Corporation and Shady Grove Special Utility District for the sale, transfer, or merger of facilities and certificate rights in Hunt County. The applicants seek to transfer all of Jacobia WSC's water certificate of convenience and necessity (CCN) number 11417 service area, facilities, and customers to Shady Grove SUD's water CCN number 11661. The transaction will result in the cancellation of Jacobia WSC's CCN number 11417. The total requested area consists of 14,004 acres with 387 customer connections.

I. Requiring Comments on the Administrative Completeness of the Application and Proposed Notice

By December 7, 2020, Commission Staff must file comments on the administrative completeness of the application and proposed notice, and both applicants and Commission Staff must file a recommendation regarding how to proceed with the application and propose a procedural schedule.

II. Filings

Unless otherwise specified, an original and ten copies of documents relating to this proceeding must be filed with the Commission's filing clerk in accordance with 16 Texas Administration Code (TAC) § 22.71. **In light of the Commission's Second Order entered in Docket No. 50664 (Commission's Second Order), this requirement will be considered satisfied if pleadings are filed with the Commission through the Interchange on the**

Commission's website as long as the Commission's Second Order is in effect.¹

Service of pleadings is typically governed by 16 TAC § 22.74. However, as long as the Commission's Second Order remains in effect, all parties must file any pleading or document with the Commission solely through the Interchange on the Commission's website and provide notice, by email, to all other parties that the pleading or document has been filed with the Commission, unless otherwise ordered by the presiding officer. It will be incumbent upon all other parties to obtain a copy of the pleading or document by accessing the Interchange at: <https://interchange.puc.texas.gov>.

All parties are required to provide their current addresses, **e-mail addresses**, telephone and fax numbers, if available, to all other parties and to the Commission by filing and serving all parties with such information. Each party must provide the Commission and all parties with updated address, **e-mail address**, telephone, and fax information if such information changes. The **e-mail addresses**, telephone and fax numbers will be included on the service list for the convenience of the parties. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

III. Ex Parte Communications

Ex parte communications with the administrative law judge (ALJ) are prohibited under 16 TAC § 22.3(b)(2). Parties must communicate with the ALJ only through written documents filed with the Commission's filing clerk and served on all parties. Questions concerning this Order, or any other order, must be submitted in writing, filed with the Commission, and served on all parties of record.
