COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND REQUEST TO WITHDRAW THE APPLICATION

On December 31, 2020, RJR Water Company, Inc. (RJR Water) filed an application for a rate change under Texas Water Code §§ 13.1871 and 13.1872(c)(2). RJR Water holds water certificate of convenience and necessity number 12139.

On April 6, 2021, the administrative law judge filed Order No. 3, which established a deadline of June 4, 2021 for the Staff (Staff) of the Public Utility Commission of Texas to file a supplemental recommendation on the administrative completeness of the application, along with a proposed a procedural schedule if appropriate. Therefore, this pleading is timely filed.

I. SUPPLEMENTAL RECOMMENDATION AND REQUEST TO WITHDRAW THE APPLICATION

In the intervening time since Order No. 3 was filed, RJR Water has not filed any information to address the deficiencies identified in Staff's February 1, 2021 recommendation on administrative completeness and notice. However, on April 17, 2021, the Staff attorney previously assigned to this case did receive email confirmation from RJR Water, included as Attachment A to this filing, stating that Staff was authorized to file a request to withdraw the application on RJR Water's behalf. Staff therefore respectfully requests to withdraws RJR Water's application and requests that this docket be closed.

II. CONCLUSION

For the reasons detailed above, Staff requests to withdraw the application on behalf of RJR Water pursuant to RJR Water's April 17, 2021 email granting Staff permission to make the request.
