**FIRST ADDENDUM TO PETITION
TRANSMITTING ELECTRONIC MAPPING INFORMATION**

I. Introduction

This First Addendum to Petition (First Addendum) transmits electronic mapping information related to the November 12, 2020 petition of Kempner Water Supply Corporation and the City of Georgetown for approval of a service area contract under Texas Water Code § 13.248 and to amend water certificates of convenience and necessity (CCN) in Bell County. Specifically, the petition seeks to transfer 7,617.6 acres of water service area from the City of Georgetown's CCN number 12369 to Kempner's CCN number 10456.
