AGREED SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

On November 17, 2020, El Paso Water Utilities Public Service Board (El Paso) and Esperanza Water Service Company, Inc. (Esperanza WSC) (collectively, the Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Hudspeth County. Specifically, El Paso seeks approval to acquire facilities and to transfer all of the water service area from Esperanza WSC under water Certificate of Convenience and Necessity (CCN) No. 12881 to El Paso's water CCN No. 10211. The requested area includes approximately 17,594 acres and 292 connections.

On May 5, 2021, the administrative law judge (ALJ) filed Order No. 10, requiring the Applicants and the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a joint motion to admit the revised maps as evidence by May 19, 2021. Therefore, this pleading is timely filed.

I. SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

Staff, with the agreement of the Applicants, requests the entry of the following additional item into the record of this proceeding as evidence for the purpose of supporting the Commission's order approving the sale and transfer to proceed:

a. Revised Mapping filed on December 4, 2020 (Interchange Item No. 3).
