RELEASE

On November 17, 2020, JLM 717 Kaufman LP (Kaufman LP) filed a petition with the Public Utility Commission of Texas (Commission) requesting the expedited release of approximately 44.9 acres of land from the boundaries of the City of Crandall's water certificate of convenience and necessity (CCN) number 11295 in Kaufman County. Kaufman LP asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Kaufman County, which is a qualifying county under 16 Texas Administrative Code (TAC) § 24.245(h)(1)-(2). Kaufman LP filed supplemental information on February 3, 2021, March 4, 2021, March 5, 2021, and March 24, 2021.

On May 13, 2021, the administrative law judge (ALJ) filed Order No. 7, requiring Commission Staff (Staff) to file a recommendation on final disposition by June 16, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION & AMENDED PROCEDURAL SCHEDULE

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to review the application. Accordingly, Staff requests that the deadline to file a recommendation on final disposition of the application be extended to June 23, 2021 and that the deadline for the petitioner to file a reply to both the CCN holder's response and Commission Staff's recommendation on final disposition be extended to June 30, 2021. Staff does not propose any additional changes to the procedural schedule adopted in Order No. 7.



II. CONCLUSION

For the reason specified above, Staff respectfully requests that the ALJ grant an extension of time and request for amended procedural schedule for Staff to file a recommendation on final disposition and the petitioner to file a reply to both the CCN holder and Commission Staff.

SUPPLEMENT TO COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED PROCEDURAL SCHEDULE

On March 16, 2021, Monarch Utilities I L.P. (Monarch) filed an application to amend its certificate of convenience and necessity (CCN) in Harris and Liberty Counties, Texas. Monarch holds water CCN No. 12893 and sewer CCN No. 20899. The requested service area consists of 121 acres and zero existing connections. Monarch filed supplemental information on May 13, 2021.

On April 16, 2021, the administrative law judge (ALJ) filed Order No. 2, establishing a deadline of June 10, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to file supplemental recommendation on the administrative completeness of the application and proposed procedural schedule for the further processing of this docket. On June 10, 2021, Staff filed a Supplemental Recommendation on Administrative Completeness and Proposed Procedure Schedule but inadvertently omitted the notice and affidavits attachment. 
