ORDER NO. 1 REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS, NOTICE, AND OTHER MATTERS, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the November 17, 2020, petition of JLM 717 Kaufman LP to amend the City of Crandall's water certificate of convenience and necessity (CCN) in Kaufman County by streamlined expedited release. JLM 717 Kaufman seeks the expedited release of its 45.8-acre portion of a 716.699-acre tract of land that lies within the boundaries of Crandall's water CCN number 13201.

I. Requiring Comments on Administrative Completeness, Notice, and Other Matters

By December 17, 2020, Commission Staff must file comments regarding the administrative completeness of the petition and notice.

Under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.254(h), this proceeding is not a contested case and no opportunity for hearing is provided. However, under 16 TAC § 24.245(h)(6), Crandall may submit a response to the Commission. Accordingly, by December 28, 2020, Crandall may submit a response, in the form of an affidavit, to the petition, and may provide briefing responsive to the legal issue identified above.
