**CSWR-TEXAS UTILITY OPERATING COMPANY, LLC'S
RESPONSE TO ORDER NO. 4**

CSWR-Texas Utility Operating Company, LLC (“CSWR Texas” or the “Company”) submits this Response to Order No. 4. The deadline for the Company to file its response is February 22, 2021; therefore, this response is timely filed.

Order No. 4 directs the Company to cure deficiencies identified in Commission Staff’s Recommendation on Administrative Completeness and Proposed Notice (“Staff’s Recommendation”), which was filed on January 21, 2021. Staff’s Recommendation directs the Company to provide (1) proof that Franklin Water Service Co (“Franklin Water”) has paid its 2001-2008 and 2014-2015 Regulatory Assessment Fees, (2) the 2019 Franklin Water annual report, and (3) a signed and notarized oath by the owners of Franklin Water. Pursuant to discussions with Commission Staff, the Company has committed to determine the amount of outstanding Regulatory Assessment Fees, if any, and to ensure payment of the fees upon completion of the proposed acquisition. The Company has also committed to file the 2019 Franklin Water annual report upon completion of the proposed acquisition. Finally, the Company has been in contact with the owners of Franklin Water and expects to receive a copy of the signed affidavit shortly. The Company will update this filing as soon as possible with the affidavit.


