
**CSWR-TEXAS UTILITY OPERATING COMPANY, LLC'S

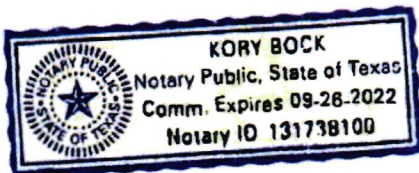
