COMMISSION STAFF’S REQUEST FOR EXTENSION

On November 20, 2020, Franklin Water Service Co. LLC (Franklin) and CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) (collectively, applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Lubbock County. The applicants seek approval to sell and transfer all of the assets and certificated service area held by Franklin Water under certificate of convenience and necessity number 12374 to CSWR-Texas Utility and cancel Franklin Water's CCN. On May 20, 2021, the applicants filed proof of notice.

On May 3, 2021, Order No. 6 in this proceeding was filed, requiring Staff to file a recommendation on the sufficiency of notice by June 14, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff discovered an issue in the proof of notice that Staff has raised with the applicants and is working with the applicants to address. In order to allow time for the applicants to file information addressing the issue and for Staff to review the additional information, Staff respectfully requests that its deadline to file a recommendation on the sufficiency of notice be extended until June 25, 2021.

II. CONCLUSION

Staff respectfully requests that its deadline to file a recommendation on the sufficiency of notice be extended until June 25, 2021.
