ORDER NO. 11 FINDING CLOSING DOCUMENTATION, AS SUPPLEMENTED AND CORRECTED, SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the closing documentation, including customer deposit information filed by Franklin Water Service Co. LLC and CSWR-Texas Utility Operating Company, LLC, regarding the sale, transfer, or merger of facilities and certificate rights in Lubbock County.

On November 30, 2021, applicants filed a fully executed bill of sale and assignment, effective November 16, 2021. On December 1, 2021, the applicants filed confidential customer deposit information. On December 13, 2021, the applicants filed a supplement to the closing documentation and corrected customer deposit information, under seal, on December 14, 2021. The applicants clarified that all customer deposits were returned or refunded and that there are no outstanding customer deposits.

On December 14, 2021, Commission Staff filed its recommendation on the sufficiency of the closing documentation and customer deposit information.

The administrative law judge finds the closing documentation, as supplemented and corrected, sufficient and satisfies 16 Texas Administrative Code § 24.239(a), (i), and (*l*). However, the transfer of certificate rights requested in this application is not complete until the application receives final approval.
