**COMPASS DATACENTERS DFW III, LLC'S
CORRECTIONS TO THE PROPOSED ORDER**

Compass Datacenters DFW III, LLC (Compass or Petitioner) files these Corrections to the Proposed Order, filed on August 2, 2021.¹ On August 2, 2021, the Administrative Law Judge (ALJ) issued a Proposed Order and Memorandum to be considered at an upcoming open meeting, and directed the parties to file corrections or exceptions to the Proposed Order by August 16, 2021. Therefore, this pleading is timely filed. In support, Compass shows as follows:

I. COMPASS'S PROPOSED CORRECTIONS

Compass proposes the following corrections to the Proposed Order:

Modify Finding of Fact No. 1, as presented below, for accuracy:

1. Compass Datacenters is a Delaware limited liability company registered with the Texas secretary of state under filing number 803462401.

Modify Finding of Fact No. 4, as presented below, to reflect the correct date:

4. On November 20, 2020, the petitioner filed a petition for streamlined expedited release of a portion of its tract of land from the CCN holder's service area under CCN number 10099.

Modify Finding of Fact No. 5, as presented below, for clarity and consistency:

5. The petition includes ~~the paperwork whereby~~ entity details demonstrating the petitioner is registered with the Texas secretary of state as a foreign limited liability company; an affidavit, dated November 20, 2020, of Jared Day, the petitioner's president and chief financial officer; general and detailed maps; a special warranty deed dated November 1,

2019, which includes metes and bounds descriptions of the parcels comprising the tract of land; digital mapping data; and proof of notice to the CCN holder.

Add a new Finding of Fact after Finding of Fact No. 5, as presented below, for clarity and completeness:

6. On December 3, 2020, the petitioner filed a supplement to the petition with the receipt evidencing delivery of notice letter sent by certified mail to the CCN holder on November 20, 2020.

Renumber all subsequent Findings of Fact.

Modify Finding of Fact No. 7, as presented below, for clarity and consistency:

7. The amended petition includes ~~the paperwork whereby~~ entity details demonstrating the petitioner is registered with the Texas secretary of state as a foreign limited liability company; an affidavit, dated May 4, 2021, of Mr. Jared Day, the petitioner's president and chief financial officer; revised maps mapping materials; a special warranty deed dated November 1, 2019, which includes metes and bounds descriptions of the parcels comprising the tract of land; a special warranty deed executed on November 1, 2019, to be effective on November 8, 2019, which includes metes and bounds descriptions of an additional parcel comprising the tract of land; revised digital mapping data; and proof of notice to the CCN holder.

Modify Finding of Fact No. 12, as presented below, for accuracy:

12. On December 29, 2020, the CCN holder filed a response to the petition.

Modify Finding of Fact Nos. 35 and 36, as presented below, for clarity:

35. Ellis County has a population of more than 47,500 people and is adjacent to Dallas County.
36. Dallas County has a population of at least one million people.

Modify Ordering Paragraph No. 5, as presented below, for clarity and completeness:

5. The Commission issues and approves the certificate attached to this Order.

II. CONCLUSION

Compass respectfully requests that the Commission adopt the corrections proposed above.


