COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

On December 3, 2020, Monarch Utilities I L.P. (Monarch) filed an application to amend its sewer certificate of convenience and necessity (CCN) 20899 in Chambers County, Texas. Monarch's application indicates that there are no customers in the areas proposed for decertification.

On July 7, 2021, the administrative law judge (ALJ) filed Order No. 8 requiring Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the sufficiency of notice and propose a procedural schedule by July 30, 2021. Therefore, this pleading is timely filed.

I. SUFFICIENCY OF NOTICE

Staff has reviewed Monarch's proof of notice, as supplemented, and recommends that it be found sufficient. As discussed in Staff's prior recommendation, Monarch provided explanation as to why they did not send notice to Chambers County MUD 2 and 3, and no Groundwater Conservation Districts with a letter of explanation or proof of the inactive status of the parties.¹

Monarch previously filed proof that the notice was published in a newspaper of general circulation in Chambers County for two consecutive weeks.

For the reasons stated above, Staff recommends that Monarch's notice, as supplemented be found sufficient.

II. PROPOSED PROCEDURAL SCHEDULE

Staff recommends the notice be found sufficient. Staff therefore proposes the following procedural schedule:

Deadline for Commission Staff to provide final maps, certificate, and tariffs (if applicable) to Applicants for review and consent	September 13, 2021
Deadline for Applicant to file consent forms with the Commission	September 27, 2021
Deadline for Staff to request a hearing or file a final recommendation on the Application	October 11, 2021
Deadline for parties to file a joint proposed order	October 25, 2021

I. CONCLUSION

Staff respectfully requests the entry of an order finding Monarch's notice sufficient and adoption of the above proposed procedural schedule.

Notice was published on May 30, 2021. Therefore, 30 days after May 30, 2021 is June 29, 2021.
